CONDITIONS FOR PNG DEALER DAY – SCHAUMBURG, IL – MAY 1, 2024

- 1) Only Individuals working full time for the applicant, or members of the applicant's immediate family, may be designated as an assistant to work at the applicant's booth.
- 2) All table holders and their assistants shall be neatly attired. Neatly attired means dress shirts, polo style shirts, or PNG shirts.
- 3) If the applicant is associated with a firm that will exhibit, buy or sell numismatic properties, the applicant is personally liable for all transactions, and enforcing all activity in accordance with the PNG By-Laws and Code of Ethics.
- 4) Although security will be furnished for the bourse area, and a security room will be established, the presence of security personnel or security systems does not constitute a guarantee against loss, or a policy of insurance, or a promise to indemnify in the event of loss by fire, theft or other casualty. Applicants are expected to insure themselves against any loss they might sustain, if they desire such protection.
- 5) Any applicant who has made false statements concerning his employees, family members or assistants will be subject to disciplinary action, and the person about whom a false statement is made may be banned from the bourse floor.
- 6) Acceptance of this application does not guarantee a bourse table. All applications are subject to acceptance by the PNG Executive Director. If the application is rejected, the fee will be refunded to the applicant.
